Ward I

Polling Division No. 1

Comprising all that portion of the Town of Truro which is bounded on the North and West by Truro Town boundaries, on the East by Hingley Avenue and Longworth Avenue and on the South by Prince Street.

Polling Division No. 2

Comprising an area bounded on the North by Robie Street, on the East by Longworth Avenue, on the South by Prince Street and its extension to the Town Boundaries, on the West by the Town Limits.

Polling Division No. 3

Comprising all that portion of the Town of Truro which is bounded on the North by Robie Street, on the South by Prince Street, on the East by Court and Elm Streets and on the West by Longworth Avenue.

Polling Division No. 4

Comprising all that portion of the Town of Truro which is bounded on the East by Ford Street, on the South by Robie Street, on the West by Hingley Avenue and on the North by Salmon River.

Polling Division No. 5

Comprising all that portion of the Town of Truro which is bounded West By Court, Elm and Ford Street, on the South by Prince Street, on the East by Revere and Park Streets, on the North by the junction of Park and Ford Streets.

Polling Division No. 6

Comprising an area bounded on the North by Prince Street, East by Willow Street, on the South by Smith Avenue, on the West by Broad Street.

Polling Division No. 7

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street and its extension to the Town boundaries, on the East by Broad Street and its extension to the Town boundaries, on the South by Smith Avenue and its Western extension to the Town boundaries and on the West by the Truro Town Boundaries.

Polling Division No. 8

Comprising all that portion of the Town of Truro which is bounded on the North by Smith Avenue and a Westward continuation thereof to Town Boundary; on the East by Willow Street; on the South by D.A.R. Tracks and on the West by Truro Town limits.

Polling Division No. 9

Comprising all that portion of the Town of Truro which is bounded on the North by the D.A.R. Tracks, on the East by Willow Street, on the South by Wynn Road to the intersection of James Street to Richardson Street and its extension to the Town line, on the West by the Town line.

Polling Division No. 10

Comprising all that portion of the Town of Truro which is bounded on the North by Wynn Road to its intersection with James Street, thence along James Street to Richardson Street and its extension to the Town Line, on the West by the Town line, on the South by the Town line and on the East by Willow Street to the Town line.

Polling Division No. 11

Comprising an area of land bounded on the North by Prince Street, on the South by Arthur Street, on the East by King Street, on the West by Willow Street.

Polling Division No. 12

Comprising all that portion of the Town which is bounded on the North by Arthur Street; on the East by King Street to the C.N.R. line; on the South by the main (incoming) C.N.R. line and on the West by Willow Street.

Polling Division No. 13

All that portion of the Town which is bounded on the North by the C.N.R. (incoming) tracks from King Street to their intersection with the Halifax Road, thence Southerly along the Halifax Road to its intersection with Glenwood Drive, thence Easterly along

Glenwood Drive to its intersection with King Street, thence Northerly along King Street to the point of beginning.

Polling Division No. 14

Comprising all that portion of the Town of Truro bounded on the North by Glenwood Drive between the Halifax Road and King Street, on the West by Halifax Road southerly to the Town Boundary, on the South by the Town Boundary, on the East by King Street from the Town boundary Northerly to its intersection with Glenwood Drive.

Polling Division No. 15

Comprising all that portion which is bounded on the North by Prince; on the East by Dominion; on the South by Arthur Street and on the West by King Street.

Polling Division No. 16

Comprising an area bounded on the North by Arthur Street, on the West by King Street, on the South by MacDonald Street and on the East by Dominion Street.

Polling Division No. 17

Comprising an area bounded on the North by MacDonald Street, on the East by Graham Avenue to the Town boundary, on the South by the Town Boundary, on the West by King Street and its extension to the Town Boundary.

WARD II

Polling Division No. 18

Comprising all that portion of the Town of Truro which is bounded on the North by Salmon River, on the East by Louise Street and its extension to the Salmon River, on the South by Prince Street, on the West by Revere Street, thence by the centre of Queen Street from Revere Street to Normandy Avenue, thence along Normandy Avenue to Park Street northerly to Salmon River.

Polling Division No. 19

Comprising an area bounded on the North by Salmon River, on the East by Normandy Avenue, on the South by Queen Street and on the West by Park Street.

Polling Division No. 20

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street; on the East by Pleasant Street; on the South by Arthur Street and on the West by Dominion Street.

Polling Division No. 21

Comprising all that portion of the Town of Truro bounded on the North by Arthur Street, on the East by Pleasant Street, on the South by MacDonald Street and on the West by Dominion Street.

Polling Division No. 22

Comprising all that portion of the Town of Truro bounded on the North by MacDonald Street, on the East by Pleasant Street and its extension to the Town Boundary, on the South by the Town Boundary and on the West by Dominion Street extension to the Town Boundary.

Polling Division No. 23

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street; on the East by Young Street; on the South by a line running through the centre line of Victoria, Faulkner and Muir Streets to Pleasant Street and on the West by Pleasant Street.

Polling Division No. 24

Comprising all that portion of the Town of Truro which is bounded on the North by Muir and Victoria Streets, on the East by Young and Faulkner Streets; on the South by Arthur Street and on the West by Pleasant Street.

Polling Division No. 25

Comprising an area bounded on the North by Arthur Street and on the East by Young Street, on the West by Pleasant Street and on the South by Fairview Drive.

Polling Division No. 26

Comprising all that portion of the Town of Truro which is bounded on the North by Fairview Drive, on the East by Young Street and its extension to the Town boundaries, on the West by Pleasant Street and its extension to the Town boundaries and on the South by the Town Boundaries.

Polling Division No. 27

All that portion of the Town of Truro which is bounded on the North by Prince Street, on the West by Young Street, on the South by Melrose Terrace and Lansdoon Place and on the East by Inglis Street and its extension to Exhibition Street, along Exhibition Street to Lansdoon Place.

Polling Division No. 28

Comprising all that portion of the Town of Truro which is bounded on the North by Melrose Terrace and Lansdoon Place, on the West by Young Street, on the East by Exhibition Street from Lansdoon Place to the Town boundary and the South by the Town boundary.

Polling Division No. 29

Comprising all that portion of the Town of Truro which is bounded on the North by Salmon River; on the East by Church and Logan and a continuation thereof to Salmon River; on the South by Prince Street and on the West by Louise Street thence crossing Queen Street diagonally to the boundary line between properties known as No. 77 and No. 83 Queen Street and continuing by the said boundary line to Salmon River.

WARD III

Polling Division No. 30

Comprising all that portion of the Town of Truro bounded on the South by Prince Street, on the West by Church and Logan Streets and the continuation of Logan Street to the Salmon River and on the East by Walker Street, and North by Salmon River.

Polling Division No. 31

Comprising all that portion of the Town of Truro which is bounded on the North by Salmon River; on the East by Lepper Brook; on the South by Prince Street and on the West by Walker Street.

Polling Division No. 32

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street; on the East by Lepper Brook; on the South by the Sydney Branch of the C.N. Railway and on the West by Inglis Street.

Polling Division No. 33

Comprising all that portion of the Town of Truro which is bounded on the North by C.N.R. Tracks; on the East by Lepper Brook; on the South by Truro Town boundaries and on the West by Exhibition Street and its Southerly extension to the Town Limits.

Polling Division No. 34

Comprising all that portion of the Town of Truro bounded on the North and East by the Town boundaries; on the South by Prince Street and on the West by Lepper Brook.

Polling Division No. 35

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street; on the South by Brunswick Street; on the East by Lyman Street and on the West by Lepper Brook.

Polling Division No. 36

Comprising these boundaries bounded on the North by Brunswick Street; on the East by Lyman Street; on the South by Adam Street and Flemming Road and on the West by Lepper Brook.

Polling Division No. 37

Comprising all that portion of the Town of Truro bounded on the North by Flemming Road and Adam Street, on the East by Lyman Street and its Extension to the Town Boundary, on the South by the Town boundary and on the West by Lepper Brook.

Polling Division No. 38

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street; on the East by Wood Street; on the South by Alice Street and on the West by Lyman Street.

Polling Division No. 39

Comprising all that portion of the Town of Truro bounded on the North by Alice Street, on the West by Lyman Street and its extension to the Town Boundary, on the South by the Town Boundary and on the East by Wood Street and its extension to the Town Boundary.

Polling Division No. 40

Comprising all that portion of the Town of Truro bounded on the North by Prince Street, on the East by Aberdeen Street, and its continuation to the Town Limits, on the South by the Town boundary and on the West by Wood Street.

Polling Division No. 41

Comprising all that portion of the Town of Truro bounded on the North by Price Street, on the East by a line between Civic No. 1216 and 1214 Prince Street, South to between Civic No. 321 and 325 Brunswick Street, thence along the centre line of Martha Avenue and its extension Southerly to the Town Limits, on the South by the Town Limits and on the West by Aberdeen Street and its extension southerly to the Town limits.

Polling Division No. 42

Comprising all that portion of the Town of Truro which is bounded on the North by Prince Street, on the East and South by the Town Boundary line; on the West by a line between Civic No. 1216 and 1214 Prince Street South to between Civic No. 321 and 325 Brunswick Street, then along the centre of Martha Avenue and its extension Southerly to the Town limits.
